President's Report: Eugene Fisher

- a. Yoga in Education: We currently have a yoga program the ES looking to have one at the MS as well. We would like to use our schools to dispel the myths about yoga especially in the inner city.
- b. Assemblyman Mile Gibson visit: Mr. O' Daniel received an award for the highest performing class in the school at the ES. Mr. Gibson toured the school and will come back for another visit in the future.
- c. Documentary Update: Still working on the documentary to change the narrative of South Los Angeles and Watts. Watts has always been a great place for education and the WLC and WLCCMS are continuing this tradition. More information on the documentary is forthcoming.
