Discussion & Review of 2019/2020 ES & MS LCAP

ES LCAP: Ryan discussed both schools action plan to provide the best possible education for our students to move the education needle. At the ES there have been new positions for teachers Math and Reading Intervention teachers. The LCAP serves as the in depth description of the school plans. We will have in house subs as opposed to Kelly Services that is familiar with the students and teachers to keep pace with the instruction instead of it being a lost day of instruction with a sub not familiar with our culture and mission. As the ES we are also adding a school counselor like we have at the MS which helps students with education and mental well being our students. We have an LCAP for parents and the public to give them transparency. We are using as much of the funds as possible to strength our educational possibilities. Is it important to know if we have any open positions which means we having savings but less services. Need to be fully staffed and do what we said we would do with the LCAP money.

MS LCAP: Miguel had made changes when he came in last year that we had this year that were in house and was helpful for our LCAP. At the MS we have a Reding Intervention teacher who will be 100% dedicated to reading intervention.

ES Budget we are budgeting for total enrollment of 385. Ended with 392. ADA of 95% is anticipated at the ES. 95%ADA is what we have always been at or exceeded. The budgeted is only based on ADA. On expenses we have added positions which means a different with the net income. At this stage in growth we want to sustain but also move the education needle. As of now our proposed net income is \$47k.

MS Budget; We are budgeting for 400 students; last year we budgeted for 395. As of now we have 405 students in Power School. We are budgeted at 95% ADA at the MS as well. The net income is projected to be at \$62K at the MS
